Tax rates in Kuwait

Payments from a contractor/subcontractor that are yet to settle their tax liabilities with Kuwaiti authorities and obtain a certificate should be withheld at a rate of 5%.



Taxation in Kuwait

In Kuwait, property is taxed through a municipal tax known as the "real estate tax". This tax is assessed on both residential and commercial properties at a flat rate of 10% of the annual rental value.
